This is the last will and testament of me John Baxter of Avening in the county of Gloucestershire. I give and bequeath unto [Mary my dear wife](#) all and singular my leasehold cottages gardens hereditaments and premises whatsoever.... Of assurance effected by me for my life with the Atlas Assurance Company my share in the Nailsworth and Avening Turnpike Road also my household goods and furniture book debts monies security for monies and all other my personal property of what nature or fund soever to hold to her my said wife her executors admors and assigns upon trust to convert the same into money as soon as may be after my decease and to divide the same equally between herself and [my two eldest children Marianne and Edwin](#) share and share alike hoping that they will do the best they can for the rest of my family and I hereby appoint my said wife Mary sole executrix of this my will witness my hand this twentieth day February one thousand eight hundred and thirty three – the mark of John Baxter – signed stated published and declared by the said testator John Baxter as and for his last will and testament in the presence of us G. H. Saunders, **Dani. Baxter**. Proved at London 17th April 1833 before the Judge by the oath of Mary Baxter widow the relict the sole executrix to whom admon was granted having been first sworn by commission duly to administer.

Gloucester Citizen 18 Apr 1923

Mr Daniel Baxter, who died at his residence, Salem House, Rodborough, at the advanced age of 90 years, was exceedingly well known and highly respected in the commercial life of Stroud and district, and even much farther afield. Born at Avening, he served his apprenticeship in the woolen cloth industry with Messrs Playne and Co., of Longford. He subsequently took up a position with Messrs Strachan and Co., Fromehall Mills, and afterwards undertook the sale of wool on commission, his clientele extending throughout England. He was unmarried, and formerly resided at Fort William, Butterow, with his sister, who lived with him until her death some seven or eight years ago. Deceased, who had lived in retirement for many years, was in his day a keen sportsman, and always of a genial and straightforward disposition gained the confidence and esteem of clients and a large circle of friends.
