Intimation is hereby given that the subscribers, John McIlvrde, Postmaster in Crieff; Robert Robertson, Tallow-Chandler in Crieff; and William Hally, Shoemaker there, Trustees and Executors of the deceased Robert McIlvrde, sometime Feuar in Crieff, ceased, as Trustees and Executors foresaid, on 21<sup>st</sup> November 1854, to be Partners, or to have interest in any of the Joint-Stock or other Companies and Undertakings aftermentioned, they having, between 20<sup>th</sup> October and 20<sup>th</sup> November 1854, both inclusive, sold and transferred the Shares and Interest therein standing in their names as Trustees and Executors foresaid – viz. 1<sup>st</sup> Perth Banking Company; 2d, Caledonian Banking Company; 3d, National Bank of Scotland; 4<sup>th</sup>, Dundee, Perth, and London Shipping Company; 5<sup>th</sup>, Scottish Union Insurance Company; 6<sup>th</sup>, Alliance Life and Fire Insurance Company; 7<sup>th</sup>, Crieff Gas Light Company; 8<sup>th</sup>, Crieff Junction Railway Company; and 9<sup>th</sup>, The Crieff and Tay Bridge Road.
