04 Jul 1844: Gentlemen, We are instructed by the Proprietors of the "London Journal of Commerce," to send you the enclosed Account; and to inform you that, as the publication of the paper is discontinued, it becomes necessary to collect all monies due to the paper immediately. We have to request, therefore, that you will be good enough to pay the amount of the enclosed Account at our Office, as above, in the course of a week from this time.

Materials and fixing the same 18s. Fender and Fire Irons suitable for same above £2. An open Fire Hot Air Stove with Double Case and Fender complete from £11 to £13. Pipe and fixing the same 15s.

 23 Jan 1844: Mr Harrington requests that you will be good enough to let him have if possible by the morning of Monday next, in order to be laid with others before the Directors of the New Zealand Company an estimate of the prices at which you can supply as they may be required Printed Forms, the same or similar to those enumerated in the accompanying list, copies of which are now enclosed, returning these copies at the same time. It is desirable that the Estimate specify the time during which each Form can be kept standing without extra charge and the price of 100, 250, 500, 750, 1000, 1500 and 2000 copies of the first, and of any subsequent editions respectively. The workmanship and materials to be all of the best kind, and the work to be executed always with the greatest possible dispatch.

Printing: Emigrant's application, Embarkation order, Terms of purchase, Agreement for ships not chartered, Reports of Directors of varying lengths, Certificates transfer of land, Circulars, Circular to Clergymen enquiring character of emigrant, Dietary, Circular transmitting Regulations, Certificate transfer of shares, Ship regulations (may be seen on application to this Office), Charter Party (to Smith and Elder and Johnston and Barrett)

09 Jul 1848: Sir, Perceiving an advertisement in the Halifax relative to Emigration to New Zealand, would you please inform me if myself and family are eligible for a free passage to Nelson. I am a farm labourer, 32 years of age, wife 29 and three children at the respective ages of 4, 6 and 8 years. An answer to the above will much oblige your obedient servant, Thomas Dean. I write a similar letter to this a few days ago which I presume you must not have received.

03 Aug 1848: Sir, I received your Instructions on Thursday last and in reference to the amounts of money which I should be able to advance for a passage to New Zealand I beg to state that I am in possession of little more than twenty pounds, which after deducting the expence to London and procuring the necessary outfits for a wife and **four** children would not leave at my disposal more than 10 or 12 pounds, a sum which I am willing to advance if the Company think sufficient. An early answer will oblige and if favourably I may procure the necessary Certificates and make other arrangements necessary for so long a voyage.
