

## **Name Index: Trade Marks**

Names followed by an asterisk are those of subsequent proprietors, the former proprietors being inserted thereafter in brackets. Trading-names are distinguished by inverted commas. Names followed by a cross-reference in brackets are either trading-names or names of subsequent proprietors.

Trademarks without numbers are those registered before 1890, when no special number was assigned to a mark. Marks applied for since 1889 are numbered, the first number being that of the application, and the second that on the Register. Where the second number is not given, the mark has not been placed on the Register.

### Background Information

Between 1868 and 1890, trade marks were administered by the Colonial Secretary's Department. Each application was registered in the correspondence system and was given an annual single number which formed the basis of the trade mark file number. In 1889 an Act was passed which provided for the administration of Trade Marks and Design copyrights by the Patent Office. Since 1890 a new trademarks registration system was established, each application was listed in the application register and assigned an application number, which formed the basis of the trade mark file number and trade mark register number.

The Trade Mark Application Registers are held at Archives NZ Wellington – Reference ABPJ 24130 W5797. These include approved and declined applications dating from 1890 and record the date, class, name and company of applicant, the particulars of the mark, the date of the registered mark and whether the application was accepted, refused, withdrawn or removed (not renewed).

The Trade Mark Registers are also held at Archives NZ Wellington – Reference ABPJ 7416 W5046. These contain pasted in copies of the trade mark forms that record the number of the application, the date, the word or device the trade mark applies to, name, address and occupation of the applicant, the class number (i.e. category the goods belongs to), a description of the goods. They also include information relating to registration renewals and occasionally information pertaining to the applicant.
