

## Oddfellows Hall, Petone

Situated on a part of Hutt Section No.4

---

The New Zealand Company Land Order that led to entitlement of this particular piece of land in Petone was purchased on 11 June 1839 by James Brodie Gordon<sup>1</sup>, Esquire, of Leadenhall Street, London.<sup>2</sup> Ownership was transferred to Dudley Sinclair<sup>3</sup> of Ham House near Richmond in Surrey on 17 August 1839.<sup>4</sup> Sinclair, aged 20 years, sailed from Gravesend on the ship 'Oriental' on 15 September 1839<sup>5</sup> and arrived in Port Nicholson on 31 January 1840.<sup>6</sup> Sinclair transferred ownership to John Carne Bidwill<sup>7</sup> on 02 September 1840<sup>8</sup> who then conveyed it to William Ebden<sup>9</sup> on 21 September 1840.<sup>10</sup>

"William Ebden, mother, brother, and servant, and three children" were described as being "On the Waiwatu" when they were "robbed of all they possessed" on 01 March 1846.<sup>11</sup> The servant was "Hunt" and the group were issued rations in the form of pork and flour in the days following.<sup>12</sup> Ebden sold the land to James Sellar<sup>13</sup> for £55 on 28 June 1850<sup>14</sup> ahead of Ebden's departure to San Francisco in December.<sup>15</sup>

In 1851 Sellar applied for a Crown Grant and on 16 November Francis Dillon Bell, the Land Claims Commissioner, reported that he was entitled.<sup>16</sup> A Crown Grant for 46 acres was issued on 16 January 1853.<sup>17</sup> Sellar, who resided on the property, gave it the name 'Seafield'.<sup>18</sup> On 30 March 1874 Sellar sold 31 acres and 3 roods to Alfred Jackson<sup>19</sup> of Wellington for £1240.<sup>20</sup> Jackson sold the same land to George Elliott Barton<sup>21</sup> on 27 January 1877 for £1450.<sup>22</sup>

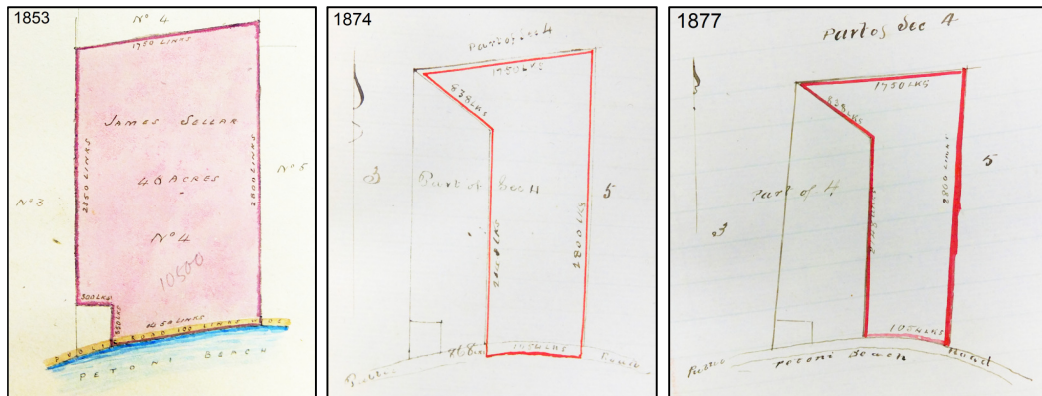

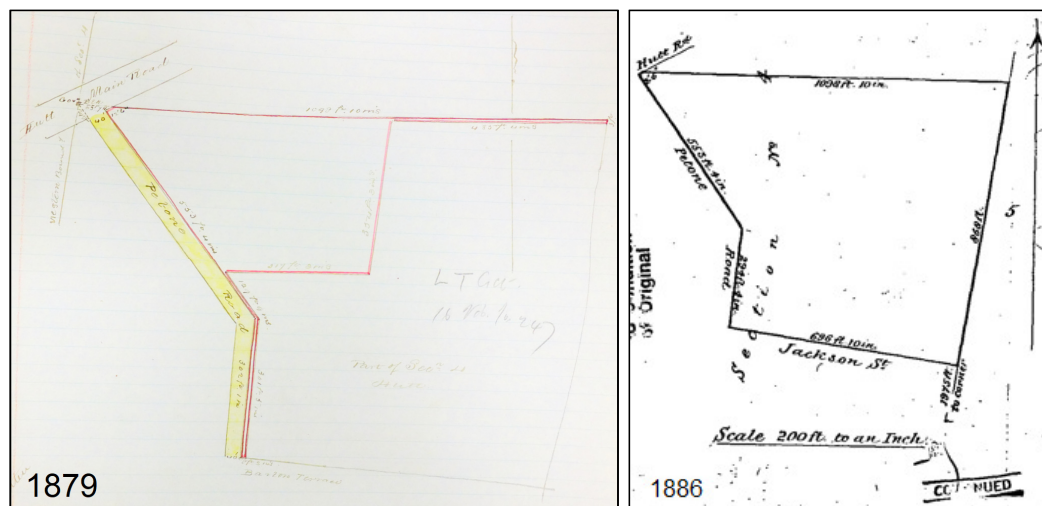

On 18 December 1878 Barton applied to bring 11 acres 1 rood and 21 perches under the Land Transfer Act and was himself the occupant.<sup>23</sup> A Certificate of Title (CT16/247) was issued on 30 January 1879.<sup>24</sup> In February 1879 the Evening Post reported that “Mr Barton has, we are informed, disposed of his house and grounds, with the stock, &c., at Petone, to Mr Manning, a recent arrival from the South Island.”<sup>25</sup> John Slade Manning also purchased an adjacent 3 acres 3 roods and 21 perches from Barton on 28 February 1879 for £1500<sup>26</sup> and retained the name ‘Seafield’.<sup>27</sup>

On 27 January 1886 Manning applied, under the Land Transfer Act, to bring both pieces of land under a single title, and was himself the occupant.<sup>28</sup> A Certificate of Title (CT 42/109) was issued on 22 March 1886.<sup>29</sup>

Also on 22 March 1886 the Evening Post announced that “Mr Jackson, of Petone, has presented the local lodge of Oddfellows with a very desirable allotment, upon which it is intended to erect a substantial hall. Up to the present, the lodge has been obliged to rent one of the ordinary public halls, but the brethren are anxious to secure a local habitation as well as a name.”<sup>30</sup>

Edwin Jackson’s obituary states that he “made a gift of a piece of land in Nelson-street to the Loyal Petone Lodge of Oddfellows.”<sup>31</sup> On 10 June 1886 “three sections of land and dwellinghouse in Petone Avenue (sometimes called Nelson-street), adjoining the Petone Jam Factory” were advertised for auction by Francis Sidey and Company on behalf of the estate of the late John Mill.<sup>32</sup> The registered office of the Hollard Jam Manufacturing Company (Limited) was in Nelson-street, Petone<sup>33</sup> and John and Charles Hollard were the jam-makers.<sup>34</sup>

The “Petone Road” land was purchased from Manning<sup>35</sup> and on 15 April 1886 Lot 51 was transferred to the Trustees of the Loyal Petone Lodge of Oddfellows, Manchester Unity No.6542.<sup>36</sup>

A notice to builders appeared in the Evening Post on 01 May 1886 “for the erection of an Oddfellows’ Hall at Petone. The building will cover 74ft by 37ft, and will no doubt be a welcome addition to the growing conveniences in this rising township.” Tenders were invited until Saturday, 15th May and specifications could be viewed at the store of Mr S. R. Johnson<sup>37</sup> at Petone. “The lowest or any tender not necessarily accepted.”<sup>38</sup>

At a special meeting of the Loyal Petone Lodge, held on 20 May, the tender of Mr D. A. Douglas<sup>39</sup>, of Wellington at £679 15s was accepted.<sup>40</sup> Mr W. L. Thompson<sup>41</sup>, “of the firm Clark and Thompson, gave his services gratuitously as architect” and Mr Committee<sup>42</sup> [sic] “placed his experience as clerk of the works at the Lodge’s disposal.”<sup>43</sup>

At the half-yearly meeting of the Petone Mechanic’s Institute, held on 30 September, members were advised that “terms had been arranged for the use of two rooms in the new Oddfellows’ Hall, which would be available about the 17<sup>th</sup> proximo.”<sup>44</sup>

On 09 October an advertisement announced a “Grand Concert and Ball” to celebrate the fourth anniversary of the Loyal Petone Lodge of Oddfellows to be held at the New Oddfellows’ Hall, Petone on Friday 15<sup>th</sup> October. The concert would feature leading Wellington Amateurs and there would be a Special Train from Wellington.<sup>45</sup>

Two days later a deputation from the Oddfellows' Lodge waited on the Petone Town Board "with reference to the roadway in front of their hall." In consequence it was decided "to put pipes in front of the hall, and also to widen the road for a few chains." The motion that "the offer of Mr McLean to fill in the roadway opposite the Oddfellows' Hall, at one shilling per yard, be accepted" was carried.<sup>46</sup>

*Evening Post 11 October 1886 Loyal Petone Lodge, M.U.I.O.O.F. – The New Lodge Buildings*

On Friday night the above lodge will celebrate their fourth anniversary in the new hall recently erected for their use in Petone Avenue. The steady progress made by the Loyal Petone Lodge is worthy of more than passing notice. Originally started by a mere handful of men employed in the railway workshops, its roll of membership has been slowly but surely increased, until it now stands fourth in the list of Lodges of the Order in the Wellington district as regards membership. During the earlier stages of its career – in fact up to the last Lodge night, the meetings have been held at the Marine Retreat, where every effort has always been made by Brother Valentine to afford all conveniences possible. For some time past, however, the necessity of increased accommodation had been foreseen by the members, and after many delays the contract for the new hall was let to Mr A. D. Douglas some four months ago.

The main hall, which is capable at present of seating over 400 people, has been built in such a way that a proper stage and accessories can be added without interfering with the present building, the cost of which as it stands amounts to some £700, but when fully completed, it is expected that the total will exceed £1,000. The seating accommodation in the main hall has been arranged with a view of securing the greatest amount of comfort in the least possible space, and the result will be most satisfactory to patrons of the hall.

Two rooms in the front of the hall have been let to the Petone Institute, and as they are roomy and comfortable no doubt the change of quarters will be appreciated by its members. The lodge-room, which is immediately above the rooms just mentioned, is a most suitable one for the purpose for which it is intended, for besides being sufficiently large to accommodate a considerable number of visitors apart from the members of the lodge, it is to be fitted up in such a way that nothing will be wanting to add to the comfort of the members. So admirably is it adapted for lodge meetings, that the local lodge of Druids have also secured it for their meetings, and no doubt other friendly societies will also avail themselves of the use of the room.

The building presents a most striking addition to the architecture of the township, and it is, we are informed, one of the best – if not the best – country halls in the province. The combined celebrations – that is, the opening of the new hall and the anniversary of the Lodge – are, as we have said, to be celebrated on Friday next, and the ceremonies and proceedings promise to be of the most imposing character. A large number of visiting brethren from Wellington and the Wairarapa have signified their intention of being present, and the Lodge has had a very large committee at work for several weeks arranging details, so that no effort has been spared to make visitors and residents remember with pleasure the opening of the new hall and the celebration of the fourth anniversary of Lodge Loyal Petone.

*Evening Post 16 October 1886*

The fourth anniversary of the Loyal Petone Lodge of Oddfellows was celebrated by a very successful concert and dance held in the large and substantially built hall which the lodge has just had erected. A special train took out over 100 city residents, and the concert was attended by over 400 persons, the hall being full in every part. The concert was probably the best ever held in the township, and was thoroughly enjoyed by the audience.

Songs were given by Mrs Parsons, Miss Randell, Messrs Todd, Copeland (Wainui-o-mata), J. A. Gooder, W. D. Lyon, and J. W. Hill. 'Auld Robin Gray' and 'A Summer Show,' by Miss Randell; 'Molly Asthore' and 'Beloved Isle,' by Mrs Parsons; 'His Lordship Winked at the Counsel' and 'Only One' by Mr Lyon; 'Sailing' by Mr Todd; and the comic songs of Mr Copeland, were encored. Two instrumental quartettes were played by Herr Mosch (piano), Messrs J. W. Hill (violin), G. J. Gray (cornet), and Hotop (violin). A duet (piano and violin) was contributed by Herr Mosch and Mr Hotop, a rondo was executed by Messrs Hotop (violin) and Manning, jun. (piano), and a pianoforte solo was given by Herr Mosch. The latter played the accompaniments to most of the vocal contributions in a manner which left nothing to be desired. Mr C. J. Hill was to have taken part in the instrumental portion of the concert, but was unable to be present.

The chair was occupied by Mr N. Valentine, Past Grand Master, who opened the evening's proceedings by giving a brief history of the rise and progress of the lodge. In the course of his remarks he stated that when the lodge was established four years ago there were only five members, while at the present time the number was over 80, with every prospect of a further increase.

After the concert hall was cleared for dancing, and the votaries of Terpsichore tripped it on the light fantastic for several hours, the music being supplied by Messrs Hoskins and Bragge. The city visitors returned by special train shortly after 1 a.m., thoroughly well pleased with the night's entertainment. The principal credit in connection with the affair is due to Mr Mothes, one of the members of the lodge, who arranged the programme, and generally exerted himself to render the celebration a success. It may be mentioned that the hall, which is a very great credit to the district, is provided with one of Kirkman's pianos, the cost of which was £85.

The hall recently built for the Petone Lodge, I.O.O.F., M.U., is erected on a section fronting Jackson-street, the main street in Petone, purchased from Mr J. S. Manning. The site, which is 87ft x 50ft, is an admirable one for such a structure, and the members of this thriving Lodge deserve great credit for displaying an enterprise which cannot do otherwise than materially augment their numerical strength. The building is a two-storied one, and was erected by Mr D. A. Douglas, Wellington. Mr W. L. Thompson, of the firm Clark and Thompson, gave his services gratuitously as architect, and Mr Committee, Petone, placed his experience as clerk of the works at the Lodge's disposal.

The main hall is 57 x 37 and is on the ground floor. It is well lighted with three chandeliers, and six side lamps. There are three Boyle's ventilators in the roof, and ten patent venetian ones in the walls, so that ventilation, so essential to the comfort of the public, has been well attended to. The seats, too, are comfortable, having good backs to them,

In the front part of the building are two anterooms and a ticket office. One of the anterooms is 20 x 19, and the other 18 x 19. They have been let to the Petone Institute at an annual rental of £26 10s. That institution has been fortunate in securing two such useful rooms, and should be well satisfied with such good and cheap accommodation.

The upper story is reached by a staircase 4ft wide, and contains the lodge-room 27 x 19, and an ante-room 10 x 10. The whole cost, including a grand piano, £85, will be about £1000. It is very satisfactory to know that various Friendly Societies in the township have applied for the use of the lodge-room, at an annual rental of £6 10s, so that the interest on the principal is forthcoming, and by economy and judicious management of the building fund it will be possible to defray the cost of the hall in a very short time. The Lodge has evidently been determined to spare no expense in meeting the requirements of the district, as their hall is furnished with every requisite for the comfort of those who patronise it.
