Letter from Alfred Domett, General Crown Lands Office, Wellington to the Commissioner of Crown Lands, Taranaki 06 April 1867.

Sir, I have the honor to forward you herewith a "Schedule of Land Orders for Colonial Forces in the Patea District received and examined in the Defence Office," the same being duly certified by the Under Secretary of that Department, the same remarks being alike applicable to this Schedule as to the Returns forwarded you in my letter of yesterday's date.
