The claimants to land at Taranaki (Waitara North) according to returns herewith, number 268 at the time the claims were made; of these 165 were men, 66 women and 37 children – 14 of whole have since died leaving the present number at 254. Of the former number only 128 came in the migration. Signed E. W. Puckey 19 October 1866

Pitoone, April 2<sup>nd</sup> 1867

To the Governor, This is to show you the names of the persons to whom the undermentioned lands belong. The boundary commences at Rangatawhi – the first man there was 'Turi' who came in the canoe Aotea the river was Patea – the boundary toward the interior is Te Ruawhahahoro thence northward to Te Whahangerengere thence to Tahunaatutawa thence to Panitahi thence ascending Rangitoto and passing over the summit of Mt Egmont it goes down to Mangawhero thence by Omoturangi to the sea, this is the last of our land we wish to dispose of it to you O Governor for twenty thousand pounds.

Note written by E. Pucky: "Turi" in the traditionary history of the New Zealanders is said to have been the great ancestor of the Ngatiruanui & Whanganui, Ngaraaru & Ngatiapa Tribes.

Questions submitted to the Hon the Minister for Native Affairs, Wellington 12 July 1867

In case any of the Absentees desiring to be put in possession of land in any district where it might be convenient to do so, in proportion to their numbers, in terms of the award at

the meeting of the 6<sup>th</sup> July instant is there any objection to its being done? Answer: None

If on meeting the Arapawa & Nelson Natives (Ropoama and his followers & Wi Te Puoho and his followers) it should be found difficult to make a final settlement of their claims, without awarding them some of the Town belt land, in the Waitara and Pukearuhe Townships, say not more than 25 acres in each case – Would the Government sanction that quantity being given to them? – Answer: Yes

Should the Government decline to establish a weekly mail between New Plymouth and Patea? If at any time a mail should be required to be carried, would the Government authorise the payment of two pounds ten shillings from place to place, or five pounds for the double trip? Answer: The Hon Mr Hall wishes to see Mr Parris on this subject. I think if Hone Pihama will take mails once a fortnight whenever it is safe at £5 the trip out and back the thing should be done without hesitation. After seeing Mr Parris I think this mail should be established, if Hone Pihama will undertake it for £5 the double trip. Once a fortnight will be sufficient at present.

In the case of the Ngatiruanui Absentees, the C. Court which sat at Whanganui, awarded sixteen acres to each of the individuals whose names were published in the Gazette of April 11<sup>th</sup> 1867 No.25, but in addition to these there are a number proferring their claims and asking what will be done for them. Are they to be admitted in the same terms as those claims disposed of by the C. Court, and the proposed award to Absentees at the meeting of the 6<sup>th</sup> July instant? Answer: I will not encourage them to hope for recognition. The notices of the Court in this district were unusually long and claims taken up to the last day.

Is it the intention of The Government to give the Absentees of the Taranaki Tribe, who have claims in the block set apart for Wm. King's Arama Karaka's tribes, an additional quantity in other blocks, in the terms of the award to Absentees at the meeting of July 6<sup>th</sup> 1867? Answer: The Government hope that they may be located within the block allotted to W. King but if Mr Parris sees that he can really quiet a large number of important men by some relaxation of this arrangement he will be at liberty to act accordingly.

Nelson 10 Nov 1866 Alexander Mackay to the Native Secretary, Wellington Sir, I have the honor in compliance with the request contained in your letter No.803 dated 24 Oct 1866, to transmit herewith a Nominal List of the Natives claiming land within the Confiscated blocks at Taranaki. The Age of the Claimants as given in the accompanying Schedule can only be taken as an approximate, as the Natives have no record or other means of marking time; the Natives date their departure from Taranaki from the sacking of Pukerangiora (a large Pah of that name) by the Waikatos, this according to Native statement happened shortly after the arrival of the Whaling party at Kapiti under Dicky Barrett. The Natives whose claims have been rejected by the Court are very discontented thereat, and I am afraid judging from their present disposition that it will be a very difficult matter, however well-intentioned the Government may be in their endeavours to appease them for their apparent loss, to give them satisfaction. They assert that if the compensation about to be offered them by the Government does not meet their views, that they will proceed to Taranaki and take possession of the land they lay claim to and let the Government put them off if they will; I merely give the statement for what it is worth to instance the sort of spirit that is evinced by them. I have heard it rumoured that the Natives resident at (Whare Kauri) Chatham Islands whose claims have been rejected by the Court, have chartered a vessel with the intention of returning to Taranaki to resume possession of the land claimed by them; if such should be the case and the Government allow these people to quietly take possession of the land; other Natives whose claims have been rejected will undoubtedly follow in their wake, and it is difficult to forsee what may be the result of such a proceeding.

Wiremu Turaki and others to the Government, Te Aro, Wellington 2<sup>nd</sup> April 1867 Friends the Runanga of the Government this is a word from us persons of the Ngatiruanui Tribe to you about the arrangement proposed by Te Ropiha Haungenge and his tribe the Ngatiawa for a sum of two thousand pounds to be given them (for their claims to land in that Block). We the Ngatiruanui object to that money being paid to them, and think it better to stop Ropiha's proposal altogether. Let him and his people go back to the Ngatiawa Country and ask money for their claims to that part, the same with the Taranaki let them go back to Taranaki and in like manner we of Ngatiruanui we will speak only of lands in our Country. We do not say anything about the money, all we ask is that a portion of our land be given back to us in the country which lies between Omoturangi thence inland and Patea thence inland. From us the people of Ngatiruanui. [Maori version enclosed with list of signatories]
