In the draft last posted I did not make entry for Mails from Lower Moutere to Thorpe. This service at present costs £20 per annum. The Mail goes twice weekly to Nga Timoti, and once weekly from Nga Timoti to Thorpe, which seems often enough. I doubt whether it can be done more cheaply than now. In the annexed draft tenders are asked from "Nelson to Havelock". At present the carrier goes to Blenheim. If it is not thought advisable to continue a through service, I think it doubtful whether it is worth while to carry Mails to Havelock only. The correspondence between Nelson and Havelock is very small.

Annotation 1: I am not aware of the arrangements exactly, for conveying mails between Lower Moutere, Nga Timoti and Thorpe, but, if they are such as to preclude the necessity for inviting tenders you may strike them out.

Annotation 2: Although the service from Nelson is only to Havelock, yet, connection is made from the latter place to Picton and Blenheim, and correspondence for these places would be forwarded, as well as for Havelock.

Services at present performed by coach may be tendered for to be performed by mail cart. Each tenderer will be required to give security as provided for on the form of tender, for a sum equal to 20 per cent on the amount of the tender, binding the tenderer to take up the service tendered for, and sign the necessary contract bond in the event of his Tender being accepted....
