Gloucester Journal 27 Oct 1794 White-Hart-Inn, Tetbury

Thomas Spearing, having taken and entered upon the above Inn, begs leave to inform the Nobility, Gentry, and others, travelling to and through Tetbury, that he has completely fitted up the same; and that he can at all times insure those, who will honour him with their company, neat and clean Post-Chaises, good Horses, and careful Drivers, and also well aired Beds, and every other accommodation equal in comfort to the first House in the Kingdom. He also laid in a large Stock of Old Port and other Wines and Liquors – and for the accommodation of Travellers, he intends having a good ordinary every day at two o'clock. Having done thus much, and being determined no attention on his part should be wanting to please his customers, and to make the most moderate charges which the times will admit of, he presumes to solicit their favours.

Gloucester Journal 23 Feb 1801 Tetbury, Gloucestershire

Wanted a person to contract to provide for the Maintenance and Clothing of the Poor in the Workhouse, for one year, from the 28th day of April next. And also a person who understands Parish Business to act as perpetual Overseer and Vestry Clerk – Any person well recommended for such Office, will be allowed a handsome Salary. It being the Wish of the Paymasters and Inhabitants to promote Industry among their Poor, they do agree to farm their Work for a set Term, having a House of Industry, supposed to contain 200 Spinners – any Person, who will contract to employ them, and Persons who would wish to engage for the above Offices are desired to certify their Intentions to the Churchwardens and Overseers, and attend a Vestry Meeting in the Church on Thursday the 12th day of March 1801 at three o'clock in the Afternoon. Timothy Shewing and Thomas Spearing – Churchwardens; James Hill, John Bish and William Holliday – Overseers.

No.408 George Spearing of the parish of Stonehouse in the county of Gloucester, bachelor and Anne Gardiner of this parish, spinster, were married in this Church by Licence 03 Jan 1822 by John Gathorne, Curate in the presence of Jasper Gardiner and Elizabeth Gardiner.

Gloucestershire Chronicle 17 Oct 1835 Cainscross, Borough of Stroud – Intended Church

The Village of Cainscross is situated at a spot where the extreme points of Three Parishes meet, namely, Stonehouse, Stroud, and Randwick, the united Population whereof exceeds 12,000. The three Churches of these Parishes are at considerable distances from that Village, and after accommodation for less than 2,800, and of which a very small proportion indeed is open to the Poor. The Inhabitants of the neighbourhood of Cainscross are consequently deprived of the blessing of attending Divine Workshop, unless it is at great inconvenience, both as regards distance and accommodation. The Population of the Village and of the surrounding neighbourhood amounts to upwards of 1,500, and is chiefly composed of the working classes in the clothing factories. A few of the Inhabitants, anxious to ensure for themselves, and their poorer brethren, the means of Public Worship, have entered into resolutions, opened subscriptions, and formed a Committee for the furtherance of this object, by the erection of a Church. It is intended immediately to endow the Church with the Seat Rents of the Private Pews; and an adequate endowment for the purpose of a district Church is secured. It is also intended to pray the Lord Bishop of the Diocese to assign to the Church a convenient district. It is a positive instruction to the Building Committee, to provide an adequate number of free sittings for the use of the poorer part of the population. The expense of the Building and fitting up, (exclusive of endowment,) is estimated to exceed the sum of £2,100 but the subscriptions amount a present to only the sum of £1,150, and the inhabitants of the Village are unable to raise the whole sum required. The Committee having received so large an amount of subscriptions, have already commenced the Building, feeling confident that the work will not be impeded by the want of means in a case of which the necessity must be apparent; they therefore beg leave to lay this statement before the Public, and to pray their aid in this very desirable work. Subscriptions will be thankfully received by the Rev Henry Cripps, of Preston, near Cirencester, the Vicar of Stonehouse; the Rev Washington Hallen, Curate of Stonehouse; the Rev W. F. Powell, Perpetual Curate of Stroud; or the Rev John Elliott, Perpetual Curate of Randwick; at the Bank of Messrs Watts, Wyatt and Co. Stroud; by Charles Cripps, Esq., at the County and City Bank, Gloucester; by Messrs Croome and Son, of Cainscross, the Treasurers; or in London, at the Banks of Messrs Jones, Loyd and Co., and Messrs Ladbroke, Kingscote and Co.

Will of Thomas Spearing

This is the last Will and Testament of Thomas Spearing of Stonehouse in the County of Gloucester. I give and devise all my Messuages, Lands, Tenements and Hereditaments whatsoever in reversion and expenctancy with their appurtenances together will all rents revenues and profits arising therefrom to my wife Elizabeth Spearing for her sole use and benefit during the term of her natural life. I also give and bequeath all my household goods plate linen china glass books prints wines and other liquors which shall be in my dwellinghouse and which shall belong to me at the time of my decease to my said wife for her absolute use and benefit and I further give and bequeath unto my said wife all monies now due to me or that may become due to my estate after my decease together with all other my effects of what kind soever to me belonging for her sole use and benefit. And I further ordain that at the decease of my said wife all the lands tenements and hereditaments herein devised and bequeathed together with all the goods chattles plate linen china glass books prints and all other effects of what kind soever then remaining shall be either sold or properly valued and equal division made share and share alike between my son George Spearing and my daughter Elizabeth Baxter or their heirs or assigns as they themselves shall hereafter determine and agree. And I do hereby appoint my son George Spearing jointly with Edwin Jeens both of Stonehouse in the said county of Gloucester to be the executors of this my last will and testament in which I revoke and disannul all former wills by me made declaring this to be my last will and testament in witness whereof I have hereunto set my hand and seal this twenty seventh day of August in the year of our Lord one thousand eight hundred and thirty-nine. Signed sealed published and declared by the said Thomas Spearing the Testator as his last will and testament in the presence of us who in his presence at his request and in the presence of each other have hereunto subscribed our names as witnesses – Richard Gardiner, Elizabeth Gardner.



The 5th May 1840 Appeared personally George Spearing of Stonehouse in the County of Gloucester Grocer and Edwin Jeens of the same place Gentleman and alledged upon oath that the foregoing paper writing contains the last will and testament of Thomas Spearing late of Stonehouse aforesaid deceased who died on the 24th day of November 1839 leaving goods chattels and credits wholly within the Diocese of Gloucester and Bristol under the value of four hundred and fifty pounds. That they are the joint executors therein named. That they will well and faithfully perform the same and render an inventory and accounts &c.
