In pursuant to an Order of the high Court of Chancery, made in a Cause of FREAK against Walters, the Creditors of George Walters, late of Blackheath, in the County of Kent, Ship-Chandler (who died in the year 1815), are, on or before the 12th day of July next, to come in and prove their debts before John Springett Harvey, Esq., one of the Masters of the said Court, at his Chambers, in Southampton-buildings, Chancery-Lane, London, or in default thereof they will be peremptorily excluded the benefit of the said Decree.
